#### Dear Friends:

When Tony and Mary Fagnant provided the resources for Blue Star Recyclers to become a reality in the Fall of 2009, we agreed upon a simple goal of doing something "special" for our community. We knew there were already places to recycle electronics, and there were sheltered workshops and day programs for people with disabilities. Yet we believed there was an opportunity to create meaningful and competitive employment for people with disabilities by ethically recycling electronics.

For the past thirteen years we have done our very best to fulfill that mission and move the dial a bit in the process.

Measured in triple-bottom line impact, to date we've created (directly and indirectly) permanent and competitive jobs for over 100 adults with disabilities by recycling over 30,000,000 pounds of electronics, which generated over \$20,000,000 in earned income and over \$20,000,000 in taxpayer savings and positive economic impact. With that, Blue Star Recyclers has become one of the preeminent social enterprise organizations in the US, and we believe this is a great place to end our first chapter – which we will call Blue Star 1.0.

In 2023 we will begin writing our second chapter (Blue Star 2.0). With most of the new structure and initiatives still in development, all I can say is... if you liked our first chapter, we think you will LOVE chapter two. Keep an eye on our website and social media platforms, where we will keep everyone updated on our progress.
